f Satan wants to stay out of trouble, he'd better avoid the small fishing village of Inglis. Florida. Inglis Mayor Carolyn Risher recently issued a proclamation revoking the Prince of Darkness' visiting rights. "Satan, ruler of darkness, giver of evil, destroyer of what is good and just, is not now, nor ever again will be, a part of this town of Inglis. Satan is hereby declared powerless, no longer ruling over, nor influencing, our citizens," Mayor Carolyn Risher declared on official town letterhead, complete with gold seal.

While the proclamation is not in reference to any singular event in the town (there spottings of Satan, photo

"As blood-bought children of God, we exercise our authority over the devil in Jesus' name. By that authority, and through His Blessed Name, we command all satanic and demonic forces to cease their activities and stuffed into fence posts like this one. depart the town of Inglis," the proclamation continues.

Racial Profiling at O'Hare
